DORRREALARROPERTY AGREEMENT R.H.C

The property referred to by this agreement is described as follows: All that certain piece, parcel or lot of land, situate, lying and being on the northern side of Tigerville Road in Bates Township, Greenville County, near the city of Travelers Rest, being shown and designated as Lot No. Fourteen (14) on a plat of Enoree Heights Property of James W. Crain made by H. S. Brockman, R.S. October 21, 1957, recorded in Plat Book "QQ", at Pages 54 and 55; and being more particularly described on plat of Property of Al David Short and Sylvia B. Short made by R. K, Campbell, May 26, 1961, recorded in the RMC Office of Greenville County, South Carolina, in Plat Book "VV", at page 94, reference to which is craved for a more complete description therof.
