

BEGINNING at an iron pin on the Northwestern side of Rosebay Drive at the joint front corner of Lots Nos. 44 and 45 and running thence along the joint line of said lots N. 52-29 W. 159.5 feet to an iron pin; thence S. 37-12 W. 170 feet to an iron pin at the joint rear corner of Lots Nos. 45 and 46; thence with the joint line of said lots S. 79-12 E. 177.3 feet to an iron pin on the Northwestern side of Rosebay Drive; thence with the Northwestern side of said Rosebay Drive N. 37-48 E. 90.3 feet to the point of beginning.

This property is conveyed subject to restrictions recorded in Deed Book 974 at page 101 in the R.M.C. Office for Greenville County, South Carolina, and to all restrictions, zoning ordinances, rights of way and easements of record and on the ground which affect said property.
