KNOW ALL MEN BY THESE PRESENTS, THAT I (or we) Odell Benson

in consideration of the sum of One Dollar, to me (or us) in hand paid, and other valuable consideration at and before sealing and delivering thereof, by the City of Greenville, receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell, and release, unto the said City of Greenville, its successors and assigns, a right-of-way for the construction of a section of the City Roadway, including necessary drainage ditches and sidewalks from

Spartanburg Street State and County aforesaid, as shown by plans prepared by the City of Greenville on and over all land which I (or we) own and are further described below, for the purpose of locating, constructing, improving, and maintaining the above described highway with the bridges and causeways thereon, and the right to construct and maintain controlled access facilities to said highway:

Said property is described as follows: ALL that piece, parcel or lot of land lying and being the City of Greenville, County and State aforesaid and lying on the East side of Spartanburg Street and having the following metes and bounds to wit: BEGINNING at a point on the Old Spartanburg Road at the Northeast corner of the property being simultaneously conveyed by me to Hattie Sue Bowens Knuckles; thence along the boundary line of said property S. 32-21 E. 184 feet, more or less, to a point at the Southeast corner of said property; thence N. 83-00 E. 35 feet, more or less, to a point on the Southwest corner of the boundary line of property now owned by said Julia Benson; thence along the boundary line of said property owned by Julia Benson N. 32-21 W. 200 feet, more or less, to an iron pin on the Old Spartanburg Road at the Northeast corner of said property owned by Julia Benson; thence along said Old Spartanburg Road S. 51-45 W. 35 feet, more or less, to the beginning point. This property is known and designated as Block Book 190-1-8A.

Said right-of-way is described as follows: BEGINNING at an iron pin at the joint front corner of lots known as 190-1-8A & 190-1-25 and running thence S. 32-21 E. 3 feet, more or less, to an iron pin; thence S. 51-45 W. 35 ft., more or less, to an iron pin; thence N. 32-21 W. 3 feet, more or less, to an iron pin on Spartanburg Street; thence with Spartanburg Street N. 51-45 E. 35 feet, more or less, to the beginning corner. This is the same property conveyed to Julia Benson from Lizzie Chandler Bolden & is recorded in the RMC office in Deed Volume 510, pg. 547 on Oct. 26, 1954 at 10:28. Julia Benson died 10/2/76 & her probate file is found in Apt. 1488 file 10. Together with, all and singular, the rights, members, hereditaments and appurtenances thereunto belonging, or in any wise incident or appertaining. It is agreed that buildings, fences, signs or other obstructions will not be erected by me (or us), my heirs, assigns or administrators within the limits of the right-of-way herein conveyed and that such buildings and fences as are now within the limits of the right-of-way herein conveyed will be moved from the right-of-way and restored in as good condition as before moving at the expense of the City of Greenville, South Carolina.

TO HAVE AND TO HOLD, all and singular, the said right-of-way and the rights herein before granted, unto the said City of Greenville, its successors and assigns forever.
