(f) Whenever the singular number is used in this Agreement and when required by the context, the same shall include the plural, and the masculine gender shall include the feminine and neuter genders and the word "person" shall include corporation, firm, partnership or other form of association.

(g) This Agreement may be executed in any number or counterparts and all of such counterparts shall for all purposes constitute one agreement binding on the parties hereto, notwithstanding that all parties are not signatories to the same counterpart.

(h) This Agreement shall be governed by and construed in accordance with the laws of the State of South Carolina.

(i) Anything in this Agreement to the contrary notwithstanding, no Partner, or any assignee of the interest thereof, shall be a person or organization prohibited by law from becoming such. Any assignment of an interest in the Partnership to any person or organization not meeting such standard shall be void and ineffectual and shall not bind the Partnership.

(j) Except as herein otherwise provided to the contrary, this Agreement shall be binding upon and inure to the benefit of the parties hereto, their personal representatives, successors and assigns.
