Pickens; thence running with the Pickens line, S. 12-30 W. 87.9 feet to an iron pin; thence, N. 77-30 W. 40 feet to an old iron pin on the edge of Hartsell Street; thence running with Hartsell Street, N. 12-30 E. 87.9 feet to an iron pin at the intersection of Hartsell Street and Jenkins Street, the point of Beginning.
