ALL that certain piece, parcel or tract of land containing ten (10) acres more or less, situate, lying and being in the County of Greenville, State of South Carolina and being a part of the Estate of the late Rev. Thomas B. Butler as shown per record of said land in the S. C. Office for Greenville County at Greer, Page 112, part of said tract of land being a part of Trust 1, and having according to said plan the following metes and bounds:

Butler by will of Merrie Mettie Latimer dated September 11, 1957 and recorded in the S. C. Office for Greenville County on September 11, 1957 at Greer, E., page 658.
