in consideration of Ten and No. 00 (\$10.00) dollars and other valuable consideration, Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto EMMA MARGARET BUTLER, her heirs and assigns forever,

ALL that piece, parcel or tract of land, situate, lying and being in the Dunklin Township of the County and State aforesaid, being a portion of the Estate of Ella Cobb Shaw, containing 21 acres, more or less, and having the following metes and bounds according to plat of W. J. Riddle, surveyor, made December 13, 1934:

"BEGINNING at a point in the road running between lands of Mamie Stewart and Rose Cobb or heretofore owned by them; running thence S. 56.10 W. 1650 feet to a stake; thence S. 44.30 E. 577 feet to a stake in a branch; thence N. 56.30 E. 1557 feet along the line of land of Rose Cobb and J. H. Perkins, or land heretofore owned by them, to an iron pin in the aforesaid road; thence N. 34.30 W. 566 feet to the beginning corner in said road."
