ALL that certain piece, parcel or tract of land containing 31.7 acres more or less, situate, lying and being in the County of Greenville, State of South Carolina and being a part of the estate of the late Rev. Thomas B. Butler as shown per plat recorded in the S. M. C. Office for Greenville County at Plat Book 222, page 49, as Tract A, and having according to said plat the following metes and bounds:

"BEGINNING at an iron pin in Fork Shoals Road at the intersection of the property belonging or formerly belonging to the Peden and Joseph Estates, N. 85-41 E. 85 feet to an iron pin in Fork Shoals Road; thence N. 81-35 E. 210 feet to an iron pin; thence S-20 W. 310 feet to an iron pin; thence N. 85-41 W. 1100.1 feet to an iron pin; thence along with the boundary of the Joseph Estate, N. 11-20 E. 888 feet to the point of beginning."

THIS is part of the same property conveyed to Thomas B. Butler as shown per deed recorded in the S. M. C. Office for Greenville County at Deed Book K, page 22 on January 27, 1937. Thomas B. Butler died testate on September 11, 1974, naming the grantor herein as his executor and trustee as may be seen by reference to the Greenville County Probate Court, Apartment No. 1-4-1, File 11. This being the same property conveyed to Martha Wettie Latimer by deed of Rev. Isaac B. Butler, dated March 11, 1937 and recorded in the S. M. C. Office for Greenville County on March 18, 1937 at Deed Book 1155, page 69, which was, in return, conveyed to the Grantor Rev. Isaac B. Butler by deed of Martha Wettie Latimer dated September 12, 1937 and recorded in the S. M. C. Office for Greenville County on September 27, 1937 at Deed Book 1165, page 69.
