THE JAMES CHILTON (Book, parcel or title) of East, citizen, living and being in Little Mountain Township, in County of Greenville, State of South Carolina, containing the extreme Northern 36 acres of the above tract surveyed in Little Mountain by David C. W. H. Green as was recorded in the H. S. Office of Greenville County, S. C. Carolina, April 16, 1871, in Deed Book 462, at page 403; and Deed of D. C. W. H. Green, to me, as was recorded in the H. S. Office of Greenville County, S. C. Carolina, June 15, 1871, in Deed Book 223, at page 111, said tract having the full wind water and ground, so-wit:
