FAYE HENDERSON COTHRAN, her heirs and assigns, forever:

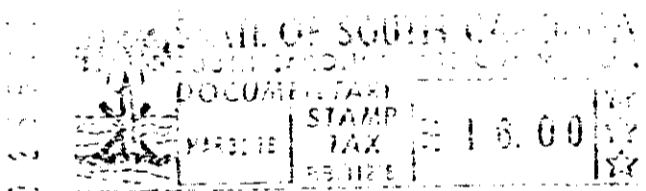
