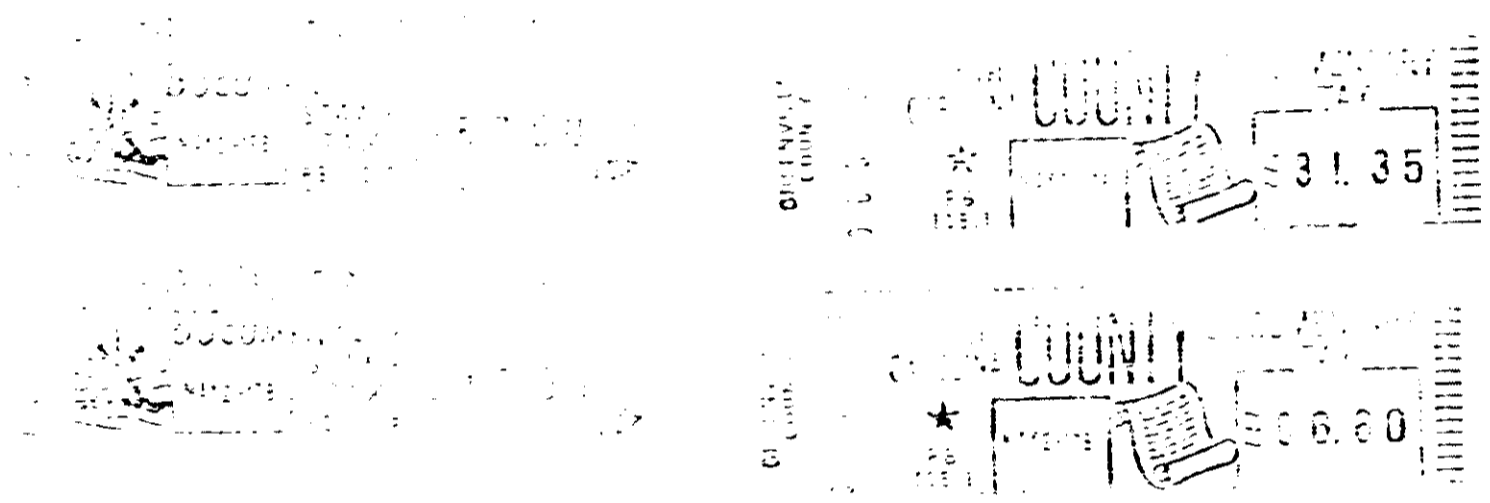
KNOW ALL MEN BY THESE PRESENTS, that Governor's Square Associates, A Partnership
