the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Grace I. Espey, her heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being on the southwestern side of Southland Avenue in the City of Greenville, County of Greenville, State of South Carolina and known and designated as Lot No. 4 on a plat entitled "Property of Southland Co., a Partnership" prepared by C. O. Riddle, Surveyor dated April 25, 1978 and recorded in the R.M.C. Office for Greenville County in Plat Book 6-H at Page 4, said lot having, according to the above referred to plat, the following metes and bounds, to-wit:

BEGINNING at a point on the southwestern side of Southland Avenue at the joint front corner of Lots 4 and 5 and running thence with the joint line of said lots S. 64-10 W., 198.87 feet; thence S. 26-29 E., 60 feet; thence N. 64-10 E., 198.2 feet to a point on Southland Avenue; running thence along Southland Avenue N. 25-50 W., 60 feet to the point and place of beginning.
