(the receipt whereof is hereby acknowledged). have granted, bargained, sold and released, and by
these presents do grant, bargain, sell and release unto the said R. E. Gregory & Co., Ltd.,

all that piece, parcel or lot of land in Greenville Township, Greenville

County, State of South Carolina, on the northern side of West Tallulah Drive,
being known and designated as Lot No. 17 as shown on plat entitled
"Survey for R. E. Gregory & Co.", prepared by W. R. Williams, Jr.,
Surveyor, dated June 8, 1976, recorded in the RMC Office for Greenville
County, S. C., in Plat Book 51, Page 60, and having, according
to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of West Tallulah Drive
at the joint front corner of the premises herein described and proper-
ty now or formerly of Montgomery; running thence with northern side of
West Tallulah Drive, S. 55-50 W. 61 feet to an iron pin on the eastern
side of West Augusta Place Street; thence with the eastern side of
West Augusta Place Street, the following courses and distances:
N. 74-10 W. 94.5 feet to an iron pin, N. 80-36 W. 71 feet to an iron
pin on the eastern side of West Augusta Place Street at the joint rear
corner of the premises herein described and property now or formerly
