KNOW ALL MEN BY THESE PRESENTS, I, LeRoy Greer,

in consideration of One and no/100 (\$1.00)-----Dollars,
and love and affection for my son,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
to H. R. Greer, his heirs and assigns forever:

ALL that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Township, being located approximately 163.7 feet back of the western side of Rutherford Road, and according to a Plat entitled H. R. Greer, dated August 3, 1978, recorded in the R.M.C. Office for Greenville County in Plat Book 65 at page 28, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the property line of Ida B. Greer and LeRoy Greer and running thence S. 33-45 W. 254.3 feet to an iron pin; thence running N. 47-15 W. 95.7 feet to an iron pin; thence running N. 33-45 E. 226 feet to an iron pin; thence running S. 71-15 E. 97.9 feet to an iron pin, the point of beginning.

GRANTOR does hereby grant to Grantee a 12 foot drive easement starting on the western side of Rutherford Road at the joint front corners of property of Mrs. L. A. Brockman and LeRoy Greer and running N. 56-15 W. 163.7 feet; thence N. 33-45 E. 12 feet; thence S. 56-15 E. 163.7 feet to a point in Rutherford Road; thence S. 33-15 W. 12 feet to point of beginning. That said easement granted by Grantor shall be binding upon his heirs and assigns forever. Said easement shall be transferable by Grantee.
