dated August 1977, recorded in the RMC Office for Greenville County in
Plat Book 6C at page 54, prepared by Dalton & Neves, Engineers.

All that tract of land in Greenville County, South Carolina, being shown
as Recreation Area, 4.096 acres, on plat of Property of Devenger Road
Land Company, by Dalton & Neves Co., Engineers, dated July 20, 1977,
recorded in Plat Book 6C at page 53 in the RMC Office for Greenville
County. A portion of this property is included in the description for
the first described property and shown on said plat as "pump station site."
