All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, and in the City of Greenville, on the South side of Goodwin Street, being described as follows, to-wit:

BEGINNING at an iron pin on said Goodwin Street 55 feet from the East side of Shumate Alley and running thence in an Easterly direction with Goodwin Street (towards Rutherford Street) 67 feet to the lot now or formerly owned by D.
