I. pipe; 190 feet, more or less, of 2" galvanized pipe; 7 - 6" valves to open right; 5 - 2" valves to open left; and 3 fire hydrants to be 3-way and open right, and is shown on a drawing entitled "Devenger Road Land Co., A Partnership to Commissioners of Public Works of the City of Greenville, S. C.", dated July 19, 1978, attached hereto and made a part of this conveyance.
