South Carolina.

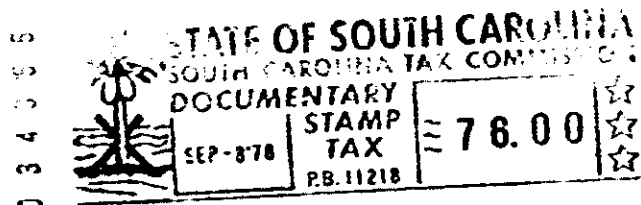
