

Thence running southeasterly, along the centerline of Woods Crossing Road and following the curvature thereof, a distance of 100.00 feet to a point (said curve having a chord distance of 99.99 feet on a magnetic bearing of South 88 degrees 46 minutes 44 seconds East);

Thence running southeasterly, along the centerline of Woods Crossing Road and following the curvature thereof, a distance of 62.58 feet to a point (said curve having a chord distance of 62.57 feet on a magnetic bearing of South 87 degrees 03 minutes 50 seconds East);

Thence running South 75 degrees 41 minutes 04 seconds West, a distance of 84.88 feet to a point located on the South right-of-way of Woods Crossing Road;

Thence running southeasterly, along the South right-of-way of Woods Crossing Road, a distance of 17.23 feet to a point (said curve having a chord distance of 17.23 feet on a magnetic bearing of South 87 degrees 05 minutes 04 seconds East);

Thence running southeasterly, along the South right-of-way of Woods Crossing Road and following the curvature thereof, a distance of 101.02 feet to a point (said curve having a chord distance of 101.00 feet on a magnetic bearing of South 87 degrees 05 minutes 04 seconds East);

Thence running southeasterly, along the South right-of-way of Woods Crossing Road and following the curvature thereof, a distance of 69.22 feet to a point (said curve having a chord distance of 69.21 feet on a magnetic bearing of South 86 degrees 34 minutes 25 seconds East);

Thence running northeasterly, along the South right-of-way of Woods Crossing Road and following the curvature thereof, a distance of 14.10 feet to a point (said curve having a chord distance of 14.10 on a magnetic bearing of North 85 degrees 16 minutes 00 seconds East);

Thence running South 75 degrees 41 minutes 04 seconds West, a distance of 519.07 feet to a point;

Thence running westerly on a curve to the right whose radius is 500.00 feet, a distance of 293.528 feet to a point located on the Southeast right-of-way of Woods Crossing Road;

Thence running North 71 degrees 46 minutes 57 seconds East, along the Southeast right-of-way of Woods Crossing Road, a distance of 90.373 feet to a point;

Thence running northwesterly, along the arc of a curve, a distance of 44.22 feet to a point (said curve having a chord distance of 44.22 feet on a magnetic bearing of North 75 degrees 12 minutes 03 seconds West) said point being the POINT OF BEGINNING
