the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Rebecca Mae Fernald, Her Heirs and Assigns, Forever:

ALL that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being shown and designated as Lots 11 and 12 on Plat of Lakewood Subdivision, which plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book Y, Pages 136 and 137, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of De Forest Circle, joint front corner Lots 12 and 13, and running thence in a northwesterly direction 169 feet to a point in the high water line of Saluda Lake, at the joint rear corner with Lot 13; thence along the high water line of Saluda Lake, the traverse line being northeasterly 172.3 feet to a point, at the high water line of Saluda Lake at the rear corner of Lots 10; thence in a southeasterly direction 228 feet to an iron pin on De Forest Circle, joint front corner Lots 10 and 11; thence in a southwesterly direction along DeForest Circle, 158.9 feet to an iron pin, the point of beginning.

BEGINNING at an iron pin in the intersection of DeForest Circle and Deborah Lane, and running thence along Deborah Lane in a southwesterly direction 137.5 feet; thence continuing in a southwesterly direction 80 feet to an iron pin, joint rear corner Lots 3 and 4; thence along the line of Lot 3, 88.8 feet to (or) together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining, to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever.
