in consideration of Two Thousand Five Hundred (\$2,500.00) Dollars,

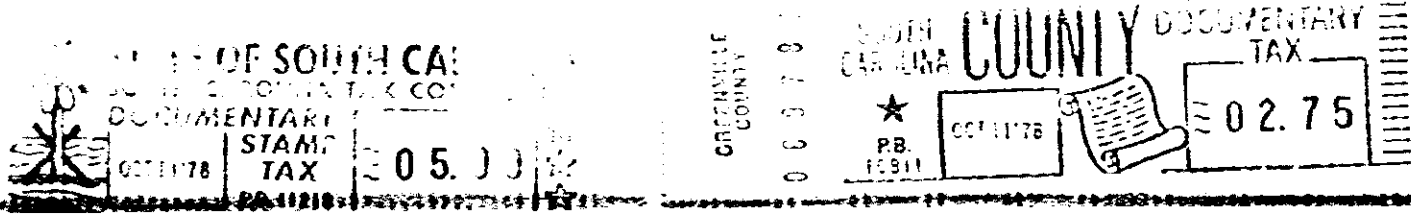
