unto Sarah H. Soubers, her heirs and assigns forever:

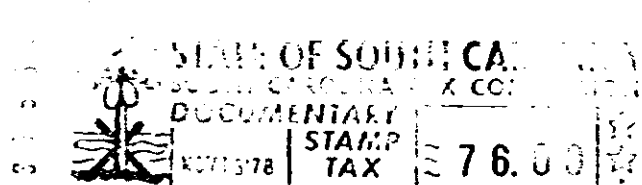
