8. The general nature of the business for which the corporation is organized is (it is not necessary to set forth in the purposes powers enumerated in Section 2.2) (12-12.2 Supplemental Code 1962)

To carry on, engage in, conduct and operate the business of interior design; fabricating, fashioning, designing and installing draperies of every kind and type; together with the fabricating, fashioning, covering, hanging, laying and installing all other interior decorations and furnishings, with any and all materials, equipment, appliances and apparatus necessary, incidental or appurtenant thereto or in anywise appertaining; residential and commercial.

To buy, sell or distribute any materials, parts, components or products required for, useful in or in anywise appertaining to the aforesaid activities, including objects of art or ornaments; at wholesale, retail, brokerage or otherwise; employing, managing and directing workmen, designers and artisans for any and all purposes aforesaid.

To carry on, conduct, operate and manage the business of furniture and clothing; buying, selling, renting, licensing the use of and in general dealing in such activities at wholesale, retail, brokerage or as general or special agents; and any activities appertaining thereto; employing, managing, directing salesmen, workmen and designers for the pursuit of such activities.

To operate, conduct and manage a school for the instruction and development of students in the design, fabrication, fashioning and installation of interior coverings and apparels, and any and all arts and

9. Provisions which the incorporators elect to include in the articles of incorporation are as follows:

This Corporation shall have the power to purchase, exchange, lease and hold such personal property or chattels and/or real property, easements, privileges, choses in action, mortgages, bonds and securities, or any interest in such. And to mortgage, sell, assign, transfer, convey, lease or otherwise alienate such property. The foregoing clauses shall be construed liberally both as to objects and powers, and it is hereby expressly provided that the foregoing enumeration of specific objects shall not be held to restrict in any manner the general and powers of this Corporation.
