I. pipe; 250 feet, more or less, of 2" Galvanized pipe; 5 - 6" valves to open right; 2 - 2" valves to open left; and 2 fire hydrants to be 3-way and open right, and is shown on a drawing entitled "Devenger Road Land Co., A Partnership to Commissioners of Public Works of the City of Greenville, S.
