The property referred to by this agreement is described as follows: All that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, being known and designated as Lot No. 136 as shown on a plat of Sans Souci Hgts, Map 4, recorded in the RMC Office for Greenville County in Plat Book Y at Page 45 and having according to said plat, the following metes and bounds, to wit: Beginning at an iron pin on the southern side of Lenore Ave. which iron pin is the joint front corner of Lot Nos. 136 and 137 and running thence along the joint line of said lots, S. 36-44 E. 164.3 feet to an iron pin; thence N. 53-32 E. 98 feet to an iron pin; thence N. 39-10 W. 156.3 feet to an iron pin on the southern side of Lenore Ave.; thence along Lenore Ave. S. 58-50 W. 90.2 feet to an iron pin the point of beginning. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
