POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS That I, Haude M. Sanford , full power and authority to do and to perform all and every act and thing whatsoever requisite and necessary to be done in and about any and all premises owned by me in making sales, purchases, constructions, settlements, conveyances, collections, assignments, granting and execution of notes and mortgages, issuance and endorsements of checks, instituting and settlement of lawsuits or other legal actions or matters, as fully and forcefully. to all intent and purposes as I might be able to do or could do if personally present, with full power and right of suspension and revocation hereby conferred upon my said agent or attorney.

Any and all acts performed by my attorney is to be binding upon the undersigned, are to carry the same force and effect as if performed or executed by me and any purchaser of property from the said attorney is to receive a full, complete, fee simple title, any person or firm receiving a note and mortgage is to receive an instrument which binds me to the same extent as if executed by me and the purchaser or other receiver of funds derived from the said attorney's actions is not to be under any duty or obligation to follow the application of the said funds.

The undersigned hereby ratifies and confirms any and all duties and acts that the said attorney may perform by virtue of and under authority of this instrument until such time as the said instrument is revoked.
