An undivided one-half (1/2) interest in and to the following described property: ALL that piece, parcel or lot of land in Bates Township, Greenville County, South Carolina and being on the western side of Cunningham Road and being designated as Lot No. 2 on a plat of property of George E. Ballenger and Arvenia M. Ballenger said plat being prepared by W. R. Williams, Surveyor, dated August, 1978 and being recorded in the R.M.C.
