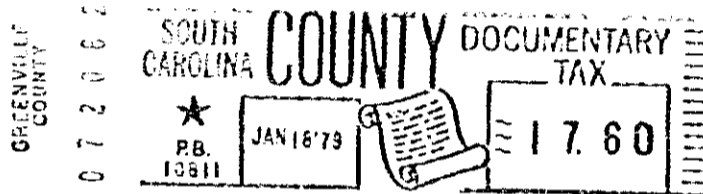
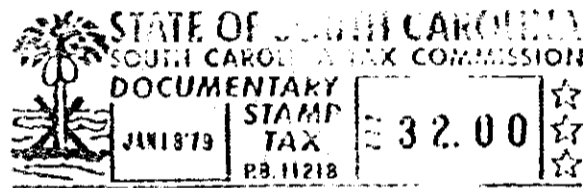
FOOTHILLS DELTA P., INC., it's successors and assigns, forever;
