FIRST AMENDMENT TO LEASE AGREEMENT

THIS AMENDMENT TO LEASE AGREEMENT, made and entered into this 29th day of September , 1978, by and between CAROLINE B. MOSELEY and LOWELL H. TANKERSLEY, CO-EXECUTORS OF THE ESTATE OF L. A. MOSELEY, DECEASED; JOANNE M. HAMMOND, INDIVIDUALLY; L. A. MOSELEY, JR., INDIVIDUALLY; and JOANNE M. HAMMOND and L. A. MOSELEY, JR., CO-TRUSTEES UNDER TRUST CREATED BY INSTRUMENT DATED NOVEMBER 1, 1974 - L. A. MOSELEY, DONOR ("Lessor") and NATIONAL PRIDE EQUIPMENT, INC. ("Tenant").

WITNESSETH:

WHEREAS, the parties entered into a Lease Agreement dated July 17, 1978 regarding property located on South Pleasantburg Drive, S. C. Highway 291, Greenville, Greenville County, South Carolina; and

WHEREAS, the parties are desirous of amending said Lease Agreement in the particulars hereinafter set forth.

NOW, THEREFORE, for and in consideration of the premises and the mutual covenants herein contained, the parties to hereby amend said Lease Agreement by deleting therefrom the legal description appearing on Exhibit A and substituting therefor the following:
