WHEREAS, BANKERS TRUST OF SOUTH CAROLINA, as Trustee of Trust B of the aforesaid Will, owns an undivided one-half (1/2) interest in the property hereinafter described, and

WHEREAS, it is deemed by the Trustee to be in the best interest of each of the aforementioned two Trusts that this conveyance be made, and

WHEREAS, BANKERS TRUST OF SOUTH CAROLINA, as Trustee of Trust B, has the power to make this conveyance which is by way of division of property jointly owned by said two Trusts.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that BANKERS TRUST OF SOUTH CAROLINA, as Trustee of Trust B under B. BUFORD WATERS' Last Will and Testament, in consideration of the sum of Five and no/100 (\$5.00) Dollars and of the premises set forth hereinabove, has granted, bargained, sold and released and by these presents does grant, bargain, sell and release unto BANKERS TRUST OF SOUTH CAROLINA, Trustee of Trust A under the Last Will and Testament of B. BUFORD WATERS, for the benefit of B. BUFORD WATERS, JR., its successors and assigns forever, an undivided one-half (1/2) interest in and to
