- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below: and
- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under excrow sugreement relating to said premises; and
 - 3. The property referred to by this agreement is described as follows:

All that lot of land with the buildings and improvements thereon situate on the west side of Sherondale Lane, near the Town of Simpsonville, Austin Township, Greenville County, South Carolina, being shown as Lot 135 on Plat of Section II, Sheet No. II of Westwood Subdivision, recorded in the R.M.C. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpy" to Bank to be due and gayable forthwith.
- 5. That the Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, is its d'scretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become wold and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legattes, devisees, administrators executors, successors and assigns, and inure to the benefit of Bank and Its successors and usaigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain ungaid shall be and ecustitute conclusive evidence of the validity, effectiveness and containing force of this agreement and any person may and is bereby authorized to rely
