in consideration of Forty-One Thousand and no/100 (\$41,000.00)----- Dollars,

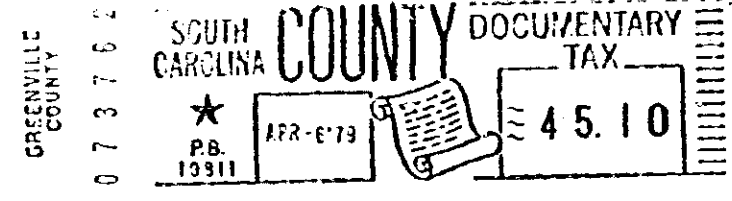
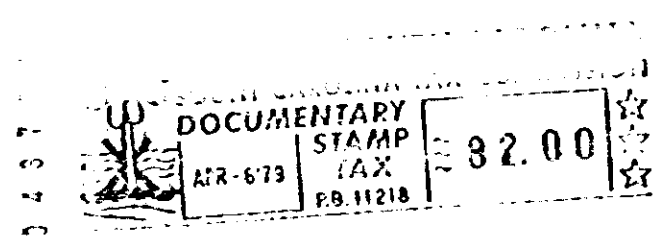
