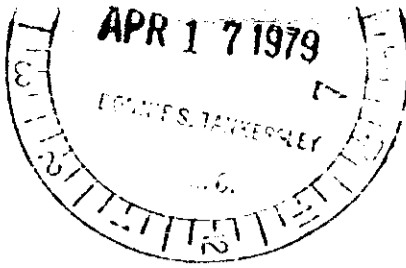

Jones all my right, title and interest in that certain piece, parcel or lot of land in Bates Township, County of Greenville, State of South Carolina, and being designated as Lot #2 on a plat of the property of Medus B. Jones TNP., Greenville County, State of South Carolina; said plat dated September 16, 1964, and surveyed by Terry T. Dill, and being more fully described as follows: BEGINNING at an iron pin in Tubb's Mountain Road and running N. 88-52 W. 230.0 ft. to an iron pin; thence S. 75-00 W 487.0 ft. to an iron pin, joint corner on Lot #1 & Lot #2; thence along line of McCauley Lumber Co, 122.4 ft. to an iron pin on joint corner of Lot #2 & Lot #3; thence N. 75-00 E 582.6 ft. to an iron pin; thence S 88-52 E 230.0 ft. to iron pin in Tubbs Mountain Road; thence along said Tubb's Mountain Road 100 feet to point of BEGINNING.
