heirs and assigns, forever; subject, however, to the restrictions and limitations above referred to.

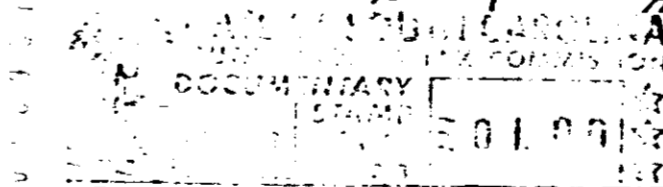
And GRACELAND CEMETERY DEVELOPMENT CO., INC., for itself, and successors and assigns, cove-
