the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Aaron P. and Jean F. Blank, their heirs and assigns forever:

All that piece and parcel or lot of land situate, lying and being on the eastern side of McElhaneey Road, being known and designated as Lot number 116 as shown on a plat of Green Valley Estates, prepared by Piedmont Engineers Service, dated December 20, 1957, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ, at pages 2 and 3, and having according to said plat the following metes and bounds:
