

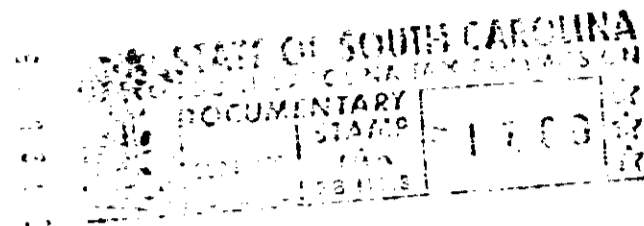

Thomason and Margaret Thomason, their heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being on the Southwestern side of Greybridge Drive, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 17 as shown on a plat entitled "Trollingwood, Section 1", prepared by Enwright Associates, dated September 30, 1971, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R at page 12 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Greybridge Drive at the joint front corner of Lots Nos. 16 and 17, and running thence with the line of Lot No. 16 S. 34-16 W. 200 feet to an iron pin; thence continuing with the line of Lot No. 16 S. 34-31 W. 103.5 feet to an iron pin at the normal pool line of a lake known as Lake Trollingwood; thence with the normal pool line of said lake N. 54-19 W. 119.6 feet to an iron pin at the joint rear corner of Lots Nos. 17 and 18; thence with the line of Lot No. 18 N. 16-13 E. 293.7 feet to an iron pin on the Southwestern side of Greybridge Drive; thence with the Southwestern side of Greybridge Drive S. 67-29 E. 105.0 feet to an iron pin; thence continuing with the Southwestern side of Greybridge Drive S. 55-45 E. 108.1 feet to the point of beginning.
