the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto

FAYE D. JONES, her heirs and assigns forever:

ALL that certain piece, parcel or lot of land, with all improvements thereon or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Anderson Ridge Road, plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 21 at Page 55, said lot having the following metes and bounds, to wit:

BEGINNING at a spike located on the southern side of Anderson Ridge Road at the joint front corner with property now or formerly of John E. Dean and running along said property line thence S. 40-44 W. 260.4 feet to an old iron pin; thence N. 43-51 W. 118.38 feet to an iron pin; thence N. 46-38 E. 49.7 feet to an iron pin; thence S. 44-05 E. 32.40 feet to an iron pin; thence N. 41-47 E. 210 feet to a nail on the southern side of Anderson Ridge Road; thence along Anderson Ridge Road S. 43-51 E. 77 feet to the point of beginning.

This is the same property conveyed to the Grantor herein by deed of J. Mack Woods, dated December 15, 1945, and recorded in the R.M.C. Office for Greenville County, South Carolina in Deed Book 284, at Page 269. This deed corrects a deed of W. L. Dean to Faye D. Jones, dated August 30, 1979, and recorded in the R.M.C. This conveyance is made subject to all restrictions, set-back lines, roadways, easements and rights of way, if any, appearing of record, on the premises or on the recorded plat, which affect the property.
