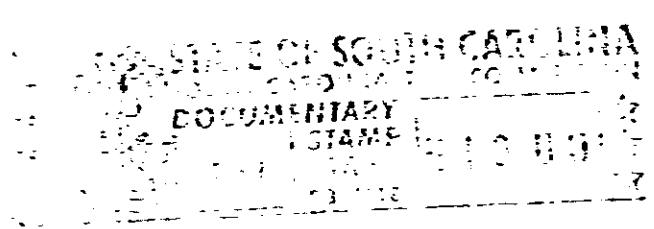
KNOW ALL MEN BY THESE PRESENTS, that Glassy Mountain Acres, Inc.
