KNOW ALL MEN BY THESE PRESENTS, that we, Richard H. Quinn, Roy W. Chatman, Mary M. Chatman and Curtis A. Nelson

in consideration of Twenty Six Thousand (\$26,000.00) and No/100----- Dollars,

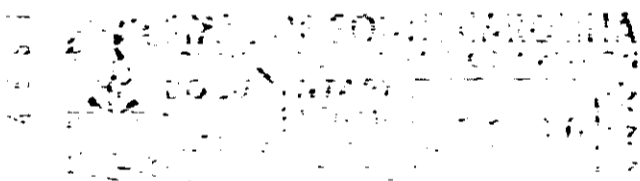
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James E. Middleton, his heirs and assign forever:

ALL that piece, parcel or lot of land, with all the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being the major portion of Lot No. 60 as shown on a plat of North Cherokee Park recorded in the R.M.C. Office for Greenville County in Plat Book C at Page 96 and according to a survey made by Dalton and Neves in January, 1959, and having the following metes and bounds to-wit:

BEGINNING at a stake on the Eastern side of Grove Road, 207 feet north from Saluda Avenue, at corner of Lot No. 59, and running thence with the line of said lot, S. 62-32 E. 171 feet to a stake on a 15 foot alley; thence with the western side of alley, N. 27-28 E. 60 feet to a stake; thence N. 64-33 W., 171.1 feet to a stake on Grove Road; thence with the Eastern side of Grove Road S. 27-28 feet to the beginning corner.

This conveyance is subject to all restrictions, setback lines, rights of ways, and zoning ordinances appearing on the property or on record in the R.M.C. Office for Greenville County.

This is the same property conveyed to the Grantors by deed of James R. Wilson, Jr. recorded in the R.M.C. Office for Greenville County in Deed Book 1113, page 802 on October 18th, 1979.
