in consideration of ---One Thousand Two Hundred (\$1,200.00)----- Dollars,

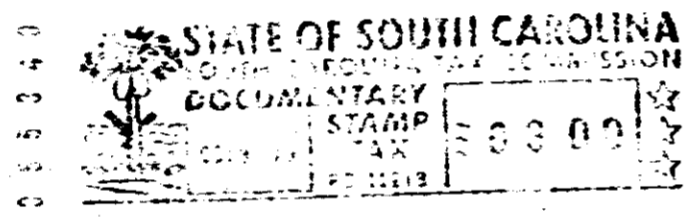
