ALL my one-half (1/2) interest, right and title to those two pieces, parcels or lots of land, lying and being in Austin Township, Greenville County, State of South Carolina, in the Town of Simpsonville, located on the North side of Fernwood Drive (formerly known as Richardson Street), adjoining other lands of Grantor and being more fully described as follows;

BEGINNING at a stake on the North side of Fernwood Drive (formerly known as Richardson Street), said stake being 200 feet from the intersection of Fernwood Drive (formerly known as Richardson Street) and State Highway #2 and running thence by new line perpendicular to Fernwood Drive (formerly known as Richardson Street) 140 feet to stake; thence by new line parallel with Fernwood Drive (formerly known as Richardson Street) 140 feet to a stake; thence by new line 140 feet to stake on North side of Fernwood Drive (formerly known as Richardson Street); thence along Fernwood Drive (formerly known as Richardson Street) 140 feet to the beginning corner.
