All that certain piece, parcel or tract of land, with all improvements thereon, situate, lying and being in Glassy Mountain Township, Greenville County, South Carolina, on the northern side of South Carolina Highway 11, containing 2.84 acres as shown on a plat thereof entitled "Survey for James W. Chambers, Sr. & Ruth T. Chambers", dated July 27, 1978, prepared by Carolina Surveying Co., and being a portion of the 70.85 acre tract shown on plat recorded in the RMC Office for Greenville County in Plat Book 6-M at page 43, with the 2.84 acre tract hereby conveyed having the following metes and bounds according to the first mentioned plat:
