I. Pipe; 1,480 feet, more or less, of 6" D. I. Pipe; 220 feet, more or less, of 2" Galv. Pipe; 1 8" Valve; 3 6" Valves; 4 2" valves; and 2 Fire Hydrants and is shown on a drawing entitled "The Vista Co., Inc. and Dee A. Smith Co., Inc. to Commissioners of Public Works of the City of Greenville, S. C.", dated October 19, 1979, attached hereto and made a part of this conveyance.
