the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

PAUL D. WEATHERS AND MARY P. WEATHERS, THEIR HEIRS AND ASSIGNS FOREVER:

ALL that certain piece, parcel or tract of land in the State of South Carolina, County of Greenville, near Travelers Rest, being shown as 2.27 acres on plat entitled "Property of Mary P. Weathers" prepared by W. R. Williams, Jr, Surveyor, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the extreme end of Westridge Court thence S. 59-31 W., 273 feet to an iron pin; thence N. 43-22 W., 473.5 feet to an old iron pin; thence N. 84-03 E., 246.8 feet to an iron pin; thence S. 41-22 E., 110 feet to an iron pin; thence S. 71-03 E., 265.5 feet to an iron pin at the Road; thence along Road turnaround S. 8-00 W., 62.7 feet to an iron pin being the point of beginning.

This is a portion of that property conveyed to the grantors by Deed of E.C. Vernon and R.H. Vernon, dated February 17, 1975 and recorded in the RMC Office for Greenville County in Deed Book 1014 at page 820 on February 20, 1975.

1. Dwelling must be set back a minimum of 35 feet from edge of Street. (This amounts to 60 feet from centerline of Street.)
2. Only one single family residence allowed on this tract. Minimum house size 1,400 square feet living area.
3. Single wide mobile home not allowed. Double wide allowed on permanent brick or block foundation, 24 inch minimum ground clearance at lowest point required. Minimum double wide trailer size 24 ft. x 55 ft.
4. Temporary single wide mobile home allowed during construction of house. This mobile home can only be set up after foundation for permanent house is constructed. A maximum of one year is allowed for the temporary mobile house.
