the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Edgar M. Norris, Jr., his heirs and assigns forever a Five Thousand (\$5,000.00) Dollar equity in the following described property.

All that certain piece, parcel or lot of land lying and being situate in the State of South Carolina, County of Greenville, in Cleveland Township, on the South side of Caesar's Head Drive, and having the following metes and bounds, to-wit:
