the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Ollie Sexton, her heirs and assigns forever,

All of our right, title and interest in and to all that certain piece, parcel or lot of land lying and being in Austin Township, Greenville County, State of South Carolina, located east of Simpsonville on the South East side of Holland Street off the Jonesville Road, and being the South Western one half of Lot #37 as shown on a plat of lands of S. T. Holland as made by J. Q. Bruce, Surveyor on October 10, 1949, and recorded in Plat Book "W" at page 103, RMC Office for Greenville County and being more fully described as follows:

Beginning at an iron pin on back corner of Lots 37 and 38 and said pin now being the center of a new cut street (Holland Street) and running thence S. 36-20 E. 200 ft. to an iron pin on corner of Lot 36; thence along line 200 ft. to a stake on line of Lot 38, said stake being the center of new cut street (Holland Street); thence along line of Lot 38 and along center of street, S. 51-30 W. 150 ft. to the beginning corner, and being a portion of the same lands conveyed to H. W. Abbott by D. L. Bramlett, Jr. by deed dated February 14, 1950, and recorded in Vol. 402, page 521, RMC Office for Greenville County.

This being the identical property conveyed to J. Emmett Sexton and Ollie Sexton by deed of H. W. Abbott dated October 6, 1953 and recorded December 15, 1953 in the RMC Office for Greenville County in deed book 490 at page 325. That the said J. Emmett Sexton died intestate on December 4, 1961 survived by the grantee, his wife, and the grantors, his children.
