to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Carroll L. and Martha A. Howard, their heirs and assigns, forever:

ALL that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, being known and designated as Lot No. 4 on plat of Property of Mary E. Page made by W. J. Riddle, Surveyor, dated May, 1948, and being re-surveyed by Robert R. Spearman, Reg. L. S. No. 3615, on March 28, 1979, and being more particularly described according to the plat of re-survey as follows, to-wit:
