 release unto JAMES R. SAPP AND J. WALTER TRIPP, their heirs and assigns, forever:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 20, Block L., on plat of Property of O. P. Mills, dated May, 1914, prepared by H. Olin Jones, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book C, at Page 176, and having, according to said plat, the following metes and bounds, to-wit:
