the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto John M. Sawyer, his heirs and assigns forever:

All my undivided interest in and to the following described property:

All that piece, parcel or lot of land situate, lying and being on the southern side of Mill Pond Court, in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 39 on plat entitled OLD MILL ESTATES made by J.
