That THE SCHOOL DISTRICT OF GREENVILLE COUNTY, hereafter referred to as Grantor, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration DOLLARS, paid to Grantor by McDANIEL ASSOCIATES, a South Carolina general partnership, and quitclaimed before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, its successors and assigns, forever:

All that piece, parcel, or lot of land in the County of Greenville, State of South Carolina, and being 1/2 of the portion of Oakland Avenue abandoned by Ordinance of Greenville City Council dated February 12, 1980, and being more particularly described as follows:

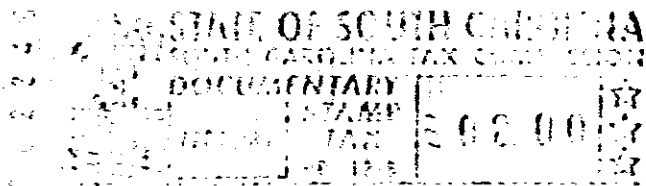

It is the intention of the Grantor to convey to the Grantee its portion of the abandoned Oakland Avenue abutting the eastern boundary of Grantee's property.

The above-described property is conveyed subject to all easements and rights-of-way affecting the premises.
